



The Emerald Coast Fitness Foundation welcomes sponsorship donations from businesses and families.

All sponsorship funds go into our operating accounts to pay the expenses of keeping our beautiful aquatic centers open to the public. We have two: [The Bernie R. Lefebvre Aquatic Center](#) in Fort Walton Beach and [Taj Renee Community Aquatic Center](#) in Destin.

Sponsorships help us keep program fees at affordable levels, enabling everyone in our community to participate in programs that increase water safety, improve physical and mental health, and contribute to healthy lifestyles and good choices for our youth, adults and senior citizens. They also assist us in making improvements to the facilities.

Business sponsorship for one pool: For \$1,000 annually, you receive promotion on that pool’s social media, a 12-month pass to the pool, and a 12 x 24 inch sign.

Two-pool option: For \$1,750 annually, you receive promotion on both pools’ social media pages, two 12-month pool passes, and a 12 X 24 inch sign at each pool.

Foundation Sponsorship: A \$2,500 annual contribution includes promotion on both pools’ social media, as well as the Emerald Coast Fitness Foundation pages. Banner Business Sponsorship: This new \$3,500 opportunity allows you to promote your business with a 4 x 6 foot banner on the fence at the end of the 8-lane, 25-yard competition pool in Destin. The Taj hosts dozens of middle, high school, and year-round club meets a year in this pool, which has a large deck and bleachers for spectators.
